6. Any dancer not present at the time of their event forfeits their entry to said event.
7. Communication, or attempted communication, with a judge or piper, by or about a competitor will result in the disqualification of that competitor.
8. All winners must be in competition dress to accept medals and trophies.
9. No entry fees can be refunded, other than for cancellation of the event by the organizers.
10. The Competition Committee reserves the right to cancel, combine, and/or add events, reject any entry, or make changes within the RSOBHD Rules and Regulations.
11. Judges' decision is final.
12. Dancer numbers will be issued on the day during registration.
13. The Organizers accept no responsibility for loss of equipment or injury.
14. Recorded music may be used.
15. Entry deadline is July 8th, 2023. Late entries will be accepted after that date with a late fee.
