No paper or electronic copy of the card will be accepted. *Any dancer not present at the time of their event forfeits their entry to said event. *Communication by a dancer or parent of a dancer with the judge or piper is grounds for Disqualification. *All winners must be in competition dress to accept awards. *No entry-fee refunds, other than for cancellation of event by the organizers. *The Competition Committee reserves the right to change any event or the time schedule. *Dancer numbers will be issued on the day during registration. *Recorded music will be used. *It is the dancer's responsibility to abide by the Three-Month Rule (may not have taken any classes, lessons, workshops, etc. with the judges for the event). *Judges' decision is final. *Aggregate Trophy (exception Primary) will be awarded to the dancer in their classification and age group with the highest place points *In the event of a protest, a fee of \$25 must accompany the written complaint. This fee will be returned if the protest is upheld.
